OSC Agenda

• Joe Mason opened the OSC Meeting with a safety message and highlighted the meeting agenda.

OSC Meeting Minutes and Highlights

• The June 19, 2025 OSC Meeting Minutes and Highlights were reviewed and approved.

2025 Mid Year Report

• Rich Wodyka led the OSC discussion on the Final Draft of the 2025 Mid Year Report on the 2024 Transmission Plan. He reported that the TAG had not provided any additional comments and questions on the Report by the July 16th deadline. Joe Mason discussed the list of projects that NCEC has requested some additional information on. Joe noted that this additional information would not change the report so he was okay proceeding with approval on the report. After discussion, the OSC voted and unanimously approved the 2025 Mid Year Report as Final. The OSC instructed Rich to distribute the Final version of the 2025 Mid Year Report to the TAG and post it on the CTPC website.

Multi Value Strategic Transmission (MVST) Response to TAG Comments

• Brant Werts led the OSC review and discussion on the additional comments submitted by SELC, NCSEA, SACE and Sierra Club related to the MVST study. He reviewed each of the SELC comments and he reviewed proposed responses to each of the comments. After discussion, the OSC agreed that Brant would produce a document of the proposed responses and send it back to the OSC for final review and approval. Once the proposed responses were approved by the OSC then Rich Wodyka would send the document back to SELC, NCSEA, SACE and Sierra Club and post it on the CTPC website.

Multi Value Strategic Transmission (MVST) Activities Update

- Brant led the OSC discussion on the upcoming MVST activities. He reported that the MVST Solutions meeting is currently being planned for August 22nd. He noted that this requires the solutions results be reviewed and approved by August 8th for distribution to the TAG and posting on the CTPC website. Brant noted that his plan is to have the initial MVST solutions results available for review at the August 7th PWG meeting. After the PWG review of the initial MVST solutions, he planned to submit the MVST solutions results to the OSC for final review and approval on August 8th to meet the distribution and posting requirement.
- Brant then presented several MVST solution examples to show the OSC how the MVST solutions results information will be documented. After review and discussion of the MVST solution examples, the OSC endorsed the format that Brant has proposed for documenting solutions results.

2025 Base Reliability and Local Economic Study Activities Update

• Sid DeSouza led the OSC review and discussion of the 2025 CTPC Study Activities Update. He noted that the interchange information for the base reliability study models had been distributed for review and approval. Sid reported that the base reliability study models are now being finalized.

RZEP Project Status Update

• Sammy Roberts noted that there was no new RZEP project information to report.

CTPC Website Update

• Rich Wodyka provided a brief update on a couple of the issues he is still having with the **CarolinasTPC.org** website.

OSC Scope

• Joe Mason led the OSC discussion on the proposed updates to the OSC Scope document. Joe indicated that NCEC needs more time to review the OSC Scope document changes that were proposed. After discussion, the OSC agreed to defer the final resolution of the changes to the next OSC meeting.

PWG Scope

• Rich Wodyka led the OSC discussion on the PWG Scope document. He reported that the PWG had reviewed and endorsed the version of the PWG Scope document that he distributed on July 21st. He noted that the updated Clean version that he sent out was now ready for OSC review and approval. After discussion, the OSC agreed to defer approval of the PWG Scope document until the OSC Scope document was ready for final review and approval at the August OSC meeting.
